

# **METRICS FOR MANAGEMENT AT A GLANCE**

- Builds rigorous, understandable, easy-to-implement, and sustainable approaches for measuring public health programs and guiding ongoing improvements.
- Strengthens government ministries, partners, and researchers by identifying and implementing targeted measurement priorities for assessing and improving health outcomes, particularly in serving the poor.
- Makes it easier for partners and programs to track their progress, to assess strategic selection of activities most likely to drive impact, and to show results of that impact.
- Works across multiple program areas including agriculture; nutrition; water, sanitation, and hygiene; reproductive, maternal, neonatal, and child health; and other health areas drawing on deep technical and measurement expertise and partnerships.

## KEY DIFFERENTIATORS

We develop a targeted selection of essential metrics with the end user in mind, overcoming common measurement challenges (e.g. too many indicators and complicated operations). Our measurement approaches inform decisions in choosing the right number and type of indicators to assess, adapt, and strengthen services. Our approach directly strengthens in-country leadership, does not require ongoing technical assistance to implement, and leads to evidence-based decision-making.

Our approach balances two fundamental aspects of effective measurement: a rigorous evidence-based focus on outcomes and strong adherence to easy-to-understand metrics. These meet the needs of end users by providing actionable information to strengthen service delivery balanced with operational feasibility. This rigor reinforce s program accountability to measurable progress, and the feasibility strengthens performance.

Our metrics drive impact. We develop straightforward and scientifically-valid metrics that provide the core information needed by government ministries and partners to inform decision-making for ongoing improvements to achieve strategic outcomes and objectives. We identify the most relevant and actionable data to routinely assess how well implementation is meeting program goals, allowing for real-time (or near real-time) adjustments.

We empower in-country program leadership. Ministries and program managers need information to make critical decisions that improve beneficiary outcomes and demonstrate measurable and replicable progress. Recognizing the need to reduce implementation and respondent burden, we will support you in developing, implementing, and analyzing focused data, and transfer those skills to your team, to inform program management and strategic planning.
